LOCAL ORGANIZATION SCHOLARSHIP FUND AFFIDAVIT

This form is due to the State Organization TWICE per year - within 30 days of local and again 6 months from date of local. An open scholarship balance report must be attached.

I, \_\_\_\_\_, of due age, being duly sworn upon my oath, depose and say:

1. I am the Executive Director/President of \_\_\_\_\_, an official local organization of the Miss America Organization ("Miss \_\_\_\_\_ State Organization").
2. Local Organization represents and warrants that Local Organization have set aside scholarships in the amount set forth below to be awarded at this years finals of the local Competition, and that such amount is no less than the amount disclosed as available to be awarded to participants in the Local Competition finals as set forth in the Local Organization's scholarship materials.
3. In the event the winner of the finals of the Local Competition or one of the runners-up relinquishes her title, Local Organization will/will not (circle one) permit the runner-up in such instance to succeed to the scholarships and awards which are applicable to the vacated position. Local Organization agrees that it will announce this policy to all interested parties prior to competition.
4. Following any expiration, termination, or non-renewal of this local's agreement with the state organization or in the event the local organization ceases to operate a local for more than one year, the local organization and its associated entities shall turn over all bank accounts (including all scholarship funds raised in the name of Miss Local and all scholarship funds designated as payable), all other funds and assets (including without limitation all sets, props, office equipment, stationery, etc.) after the payment of all debts previously contracted for and incurred in good faith (or, if such debts have not matured, local organization and its associated entities shall transfer such other funds and assets, subject to such debts, but only to the limit of the funds and assets so transferred), and shall assign all state and/or federal trademarks owned or held by the local organization and/or its associated entities, to the State Organization, if there should be one, or, if none, to the Miss America Organization.
5. I understand that the statements contained in this Affidavit are being relied upon by the Miss America Organization and the Miss \_\_\_\_\_ Organization and that if such statements are willfully false, that the Local Organization and I are subject to prosecution and to all further remedies available to the Miss America Organization as set forth in the State Organization Agreement.
